About the Opportunities

Appointments are for a two-year (renewable) period commencing from April 2024.

The Committees are established under terms of reference set by the RIAC Board of Directors and play an integral role in the overall decision-making obligations of the Board. Each Committee currently comprises two RIAC Directors and meets a minimum of 4 times per year. RIAC is seeking additional independent members to broaden the membership of the Committees.

The FAC provides independent assurance and advice on accounting, financial management, internal controls and associated risk management matters.

The GovCo is focused on ensuring RIAC's policies, procedures and culture support high quality accountable and effective governance.

The R&SC is focused on the functioning, accountability and effectiveness of RIAC's risk tolerances, risk management and strategic planning.



RIAC's Board and Committee are made up of volunteers and therefore members of the Committees are not remunerated.

RIAC is a regional organisation based in Victoria, with a geographically dispersed Board, and its Committees meet online, therefore we are flexible about the location of members, though our preference is to recruit members from our service catchment areas.

RIAC prefers to recruit people with lived experience of disability as committee members.

Independent Members must have skills, knowledge and experience relevant to the functions of the committees, such as finance, budgeting and audit (FAC), governance and policies (GovCo) and risk or strategy (R&SC).
